Re: Hazelbury Primary School Street

In November 2021 the Council, in partnership with Hazelbury Primary School, made the School Street on Westerham Avenue N9 permanent. This is part of the Council's Healthy Streets approach, working to create cleaner, greener and safer streets, and promoting sustainable and active travel.

We have worked with schools to introduce Automatic Number Plate Recognition (ANPR) camera enforcement to assist with safety in the School Street walking and cycling zone. This also removes the necessity for staff and volunteers to marshal the gates. Some schools may choose to continue to marshal alongside the ANPR enforcement to further enhance the scheme. Without marshalling, motor vehicles could continue to enter the zone if drivers ignore the signs (they will receive a fixed penalty notice). Please be aware of the type of scheme in operation at Hazelbury Primary School, which is ANPR only.

The scheme will continue to operate from Monday to Friday during term time only. We have worked with schools to establish the operating times. These are displayed on the signs and may have changed from those during the earlier trials. The extent of the pedestrian and cycling zone remains unchanged.

Permission to access the School Street during the hours of operation can be granted to residents (who live within the zone), local businesses, and blue badge holders – these are known as exemptions. Residential properties that are within the zone will continue to be entitled to an exemption for their vehicle(s) to enable entry and exit of the zone during the times of operation. There is no charge for School Street exemptions.

Camera enforcement is by number plate recognition; therefore, it is essential that all residents ensure they have registered their vehicles for an exemption with the parking services department before the commencement date of Monday 9th May 2022. Any unauthorised vehicles entering the zone will be issued with penalty charge notices during the hours of operation.

Parents / carers and blue badge holders who require specific access to the school during the hours of operation for the purpose of collecting or dropping off a child should contact the school administration via the school office who will process their application for an exemption. There is no charge for exemptions.

The commencement date for camera enforcement is 8:30am **Monday 9th May 2022**.

Monitoring of the scheme is ongoing and includes monitoring of traffic volumes and working with schools to understand changes in travel habits of pupils, staff and parents.
